# Az egészségesen várható élettartam növelése a fenntartható fejlődési célok kiemelkedő teljesítése által Boosting gains in healthy life expectancy

THROUGH EXCELLING IN ACHIEVING SDGs

A számítások közönséges legkisebb négyzetekkel becsült lineáris regresszióval és két független részminta hipotézistesztelésével történtek. A születéskor egészségesen várható életkor elméleti maximuma 76,7 évre becsülhető, mely 9,9 év potenciált jelent Magyarország esetében. A fő javaslatok jellegük alapján vagy elsődlegesen az egészségügyi rendszerhez kapcsolódnak, vagy átfogónak tekinthetőek pl. rendszer szintű folyamatokat céloznak meg. Az első csoportba sorolható a hatékony közegészségügy és több prevenció az életstílussal összefüggő kockázati tényezők csökkentése érdekében, a kórházi szolgáltatásokról a járóbeteg-ellátás felé történő elmozdulás, illetve a fekvőbeteg-ellátás területén az egynapos sebészet előnyben részesítése. A második kategóriát alkotja a felelős fogyasztási és termelési minták (beleértve a gyógyszerekét) terjesztése, a környezeti ártalmak megszüntetése, a karbonsemleges energia előmozdítása, fenntartható élelmezési rendszerek létesítésének ösztönzése és a várható élettartam iskolai végzettség szerinti különbségének mérséklése az oktatási rendszerben töltött évek fokozása által.

A new generation of inequalities within and between countries is emerging with divergence in enhanced capabilities (e.g. access to quality health). These discrepancies have to be reduced and further numerous conditions have to be met in order to fulfil the 3<sup>rd</sup> Sustainable Development Goal of "Ensuring healthy lives and promoting well-being for all at all ages". This article aims at investigating the theoretical maximum of healthy life expectancy at birth for 2016 and possible required measures for obtaining it within the framework of sustainable development. Calculations were based on ordinary least squares linear regression and hypothesis testing of two independent subsamples. The theoretical maximum of 76.7 years bears a potential of 9.9 years for Hungary. The nature of the main recommendations is either primarily related to the health system or it can be considered as comprehensive, i.e. addressing systemic processes. The first group encompasses effective public health care and more prevention in order to cut down lifestyle risk factors, shifting from hospital services towards outpatient services, and preferring day surgery within inpatient services. The second category is composed of spreading responsible consumption and production patterns (including that of pharmaceuticals), eliminating environmental harms, promoting carbon neutral energy, spurring the establishment of sustainable food systems and mitigating the education gap in life expectancy through augmented expected years of schooling.

#### INTRODUCTION

By designating the direction of the research and carrying out the analysis, the applied approach was inspired by the endeavour of "Enabling everyone to lead a long and healthy life" and of fostering system-level understanding in the interest of realising one of the most propitious development scenarios. Hence, the predominant focus is on improving the Healthy life expectancy at birth<sup>2</sup>, which can be considered as enhanced capability with divergence within and between countries opposite to the basic capability indicator Life expectancy at birth<sup>3</sup>, which demonstrates slow convergence thanks to the declining inequalities.<sup>4</sup> This study is the extended version of the article "Releasing the Potential in Human Resources" to be found in the book of proceedings "Living Longer, Working Smarter, Ageing Well International Conference" hold on the 18<sup>th</sup> and 19<sup>th</sup> May of 2020 and organised by Corvinus University of Budapest.<sup>5</sup>

Two research questions were formulated:

- 1. What was the theoretical maximum of the Healthy life expectancy at birth in 2016?
- 2. By means of which major measures can this maximum be achieved?

The literature review with regard to the healthy life expectancy disclosed similar studies focusing on life expectancy or on healthy life expectancy from diverse points of view and identified a presumed gap in the research field. For instance, van Hedel et al. examined the association between education and mortality in the United States and 7 European countries.<sup>6</sup> Lhachimi et al. estimated the potential gains in life expectancy and in morbidity-free life expectancy for 11 EU countries by assuming best practice lifestyle risk factors.<sup>7</sup> Loichinger and Weber compared the working life expectancy at age 50 with healthy life expectancy.<sup>8</sup> Nonetheless, I did not find any articles from the last 5 years, which would handle the estimated maximum of the healthy life expectancy at birth in EU countries through the complex lens of sustainable development<sup>9</sup> and would attempt to quantify the contribution of the particular components.

As Figure 1 depicts, the applied approach was built around selected SDGs by ascribing the central role to the 3<sup>rd</sup> goal, which is the main subject of this study. In order to benefit from the entire potential of the synergies arising from the repercussions within the set of the outlined SDGs, action plans and priorities should be in accordance with the interrelatedness of the respective goals. Transforming the fundamental pillars (with focus on food and agriculture, education, power system, environmental health, sustainable economy) is indispensable for achieving good health and well-being. The scope of the analysis is the European Union with particular reference to Hungary.

### DATA ANALYSIS AND FINDINGS

#### DETERMINING THE THEORETICAL MAXIMUM OF THE HEALTHY LIFE EXPECTANCY AT BIRTH

As result of a profound data collection, the dataset is restricted to three relevant variables covering 29 countries<sup>11</sup>:

- Preventable causes of mortality<sup>12</sup> (predictor, denoted as X<sub>1</sub>),
- Ambient and household air pollution attributable death rate<sup>13</sup> (predictor, denoted as X<sub>2</sub>),
- Healthy life expectancy at birth<sup>14</sup> (dependent variable, denoted as Y).

Figure 2 illustrates that Cyprus and Sweden occupy the most favourable position in the space of the predictors. Contrary to these outstanding states, Hungary pertains to the country group with the most disadvantageous values along both dimensions, which calls for immediate progress.

The following Ordinary Least Squares Linear Regression model can be built on the predictors for estimating the Healthy life expectancy at birth:

Table 1 and 2 recapitulate the main results of the model: all beta parameters are significant based on the individual t-tests and on ANOVA. The confidence interval of the intercept at a significance level of 5% is [76.0854;77.2297] years. The R square is 95.84%, the adjusted R square is 95.52%. Regarding the statistics of the residuals, three countries have a centred leverage value above 0.2: Lithuania (0.2054), Greece (0.2431) and Romania (0.2730). Similarly, Romania has the highest Cook's distance (0.1527), but as it falls below 1, there is not any outlier. In order to assess multicollinearity, the variance inflation factor was determined:  $VIF(X_1)=VIF(X_2)=1/$  $[1-r^2(X_1,X_2)]=2.9988$ , which nearly coincides with the level of tolerance (3). Three alternative linear regression models and one regression model containing interaction of the predictors were created for validating the result for the maximum of the Healthy life expectancy at birth by relying on two data sources with various composition. The estimates of the intercept were practical of the same order of magnitude: they varied between 76.66 and 77.91 years in the models with adjusted R square ranging from 94.22% to 95.90%, consequently, the presented model is the most prudent. At the state of medicine in 2016, the intercept indicates the maximum, which is equivalent to a potential of 9.86 years in case of Hungary. The model underestimates the Hungarian fact value (), for this reason, the decomposition of the potential can be calculated as follows:

Cutting back all preventable causes of mortality by dint of effective primary prevention and

public health care:  $abs\left(\hat{\beta}_1 \cdot X_1^{HU} \cdot \frac{\hat{\beta}_0 - Y^{HU}}{\hat{\beta}_0 - Y^{HU}}\right) = 8.68 \text{ years}$ 

Eliminating environmental harms:  $abs\left(\hat{\beta}_2 \cdot X_2^{HU} \cdot \frac{\hat{\beta}_0 - Y^{HU}}{\hat{\beta}_0 - Y^{HU}}\right) = 1.18$  years

Regarding the lifestyle risks<sup>15</sup>, mitigating Dietary risks, Alcohol consumption and risks arising from Low physical activity could beneficially influence the Healthy life expectancy at birth as shown in Table 3.

Spain represents the maximum healthy life expectancy at birth (73.8 years) in the sample. Its practice affirms that generally effective public health and health care interventions are appropriate but not sufficient means in vanquishing premature mortality, furthermore, it projects the growing needs in ageing societies for health care and long-term care for elderly

people.<sup>16</sup> Involving relevant stakeholders<sup>17</sup> and providing them with health risk assessment tool can establish an early warning system, which could alleviate overloaded health care systems. Regarding occupational safety and health risks, the Third European Survey of Enterprises on New and Emerging Risks (ESENER 3 – 2019) pointed out the relevance of psychosocial risks and the impact of digitalisation on the health and safety of human resources.<sup>18</sup>

Table 4 summarises the health impacts of exposure to major air pollutants.<sup>19</sup> In Hungary, households were responsible for the emission of 86% of particulate matters with a diameter of 2.5  $\mu$ m or less, while main nitrogen oxides (NO<sub>x</sub>) emitters were Agriculture, Households, Transportation, Manufacturing, and Electricity, gas, steam and air conditioning supply in 2017.<sup>20</sup> For these reasons, accomplishing the 7<sup>th</sup> SDG of "Ensuring access to affordable, reliable, sustainable and modern energy for all" could be a remedy against air pollution.

#### Shifting from inpatient towards outpatient services, preferring day surgery

In order to estimate the recommended level for the ratio between Outpatient care and Inpatient care, the 29 previous countries were aligned in ascending order according to their healthy life expectancy at birth. Both the cumulative average healthy life expectancy at birth and the cumulative average ratio (Expenditures on outpatient care per capita / Expenditures on inpatient

care per capita<sup>21</sup>) were weighted based on the total population<sup>22</sup> of the underlying countries. Although the trendline (Figure 3) is not monotonous, the proposed ratio is above 105%.

Two-sample asymptotic z tests confirm that the mean of the country group with higher ratio surpasses that of the country group with a lower ratio. Nevertheless, these results are valid on an aggregated level, which view mitigates the influence of country-specific circumstances (e.g. effects of climate). Particular cases (like France) serve as counter-examples for that the preponderance of inpatient care may lead to high healthy life expectancy at birth but revising the allocation of expenditures may enhance efficiency similar to the case of the excelling Spain. By applying a low ratio of 92.75%, Hungary performs 66.8 years of healthy life expectancy at birth, which could be ameliorated by means of a reconsidered distribution of health expenditures in favour of outpatient services. Table 5 sums up the average values of both country groups depending on the ratio.

16 main and 4 sub-procedures<sup>23</sup> were analysed whether they offer the opportunity for an enlarged proportion of day surgery: either a convergence towards 100% or a considerable potential for growth proves to be feasible in numerous cases.<sup>24</sup> The relationship between the healthy life expectancy at birth and the share of day cases finds evidence in a positive medium correlation. Its value lies between +0.318 and +0.436 based on the sample of OECD countries ranging from 22 to 28 depending on the respective procedure.

## **Responsible consumption patterns**

The 12<sup>th</sup> SDG envisages "Ensuring sustainable consumption and production patterns", which embody avoiding overconsumption of medicaments as well. The interrelatedness between the Healthylife expectancy at birth (Y - dependent variable) and the Expenditures on pharmaceuticals and medical devices<sup>25</sup> (X – predictor) are scrutinised by dividing the countries into two groups (whether the healthy life expectancy exceeds 71.5 years) as two distinct phenomena prevail. The first cluster contains selected best practice the Mediterranean and Scandinavian countries where the healthy life expectancy at birth reached at least 71.8 years, whilst the second one incorporates members joined the EU in 2004 and thereafter.

The efficient medical consumption patterns of 2017 can be demonstrated by virtue of the equations below (dotted lines on Figure 4):

- above 71.5 years: Y = 0.0102 · X + 68.270 (R square: 86.12%, adjusted R square: 82.65%, both beta parameters are significant);
- below 71.5 years:  $Y = 0.0151 \cdot X + 63.335$  (R square: 70.67%, adjusted R square: 63.33%, both beta parameters are significant).

Hungary's figure of 448.89 EUR represents a level of expenditures, which could enable – in case of efficient use and treating health problems not symptom-centric – to maintain a healthy life expectancy at birth of 70.1 years in a newcomer country or even 72.8 years in a more developed state. The two functions draw the attention to the dissimilarity of views and raise the question of the nature of the process of catching-up, i.e. whether the former satellite countries and several Western nations will be able to follow the traces of best practice states and to increase the healthy life expectancy at birth without an unjustified and thus avoidable medicament overconsumption. In addition, the models anticipate that the higher the achieved healthy life expectancy amounts, to the less extent medical products, appliances and equipment can contribute to the further increment in the healthy life expectancy.

The responsible consumption patterns shed light on the expansion of overweight (including obesity).<sup>26</sup> Its measured and self-reported percentage<sup>27</sup> varied between 41.8% and 72.5% among adults in 2017 in the 26 European OECD countries, while the example of Japan (25.9%) and South Korea (33.7%) testify that a viable compromise does exist if efforts are complemented on the one hand by the fight against food waste, on the other hand, by the eradication of malnutrition.

The 13<sup>th</sup> SDG summons to "Take urgent action to combat climate change and its impacts", whilst the 2<sup>nd</sup> SDG strives to "End hunger, achieve food security and improved nutrition and promote sustainable agriculture". As augmentation in global average temperature is accompanied amongst other impacts and risks by decreasing crop yields and exacerbating heat-related mortality and morbidity<sup>28</sup>, it would be crucial to limit the global mean surface temperature change to 1.5°C relative to pre-industrial levels (i.e. keeping the concentration below 430 ppm  $CO_2$ -equivalent by 2100<sup>29</sup>). Electricity & heat, transport, industry and construction, agriculture rank among the sectors with the largest emissions of greenhouse gases: Agriculture engenders 11% of the emissions<sup>30</sup>, whereas around one third of the global food production is lost or wasted. The Food Loss Index expresses the percentage of the lost food from post-harvest up to (but not including) the retail level and its global estimation amounts to 14%.<sup>31</sup> The difference can be

led back to the retail and consumption levels.<sup>32</sup> In spite of overproduction, 821 million people are undernourished worldwide. The estimation that "1.5 billion people are affected by one or more forms of micronutrient deficiency" alludes to the need for quality aliment e.g. through multiplying the area under organic farming.<sup>33</sup>

## MITIGATING THE EDUCATION GAP<sup>34</sup> IN LIFE EXPECTANCY

The education gap in life expectancy at age 30 was 12.6 years for men and 6.4 years for women in 2016 in Hungary. Bifurcating the sample consisting of 21 European countries into more and less developed societies according to the education gap, a significant difference in the mean of the expected years of schooling<sup>35</sup> for males can be perceived. In order to overcome its education gap, Hungary should amplify the expected years of schooling for males from 14.8 years to 16.5-16.8 years within the framework of the 4<sup>th</sup> SDG of "Ensuring inclusive and equitable quality education and promote lifelong learning opportunities for all.<sup>36</sup> Concerning females, the relation between the education gaps can not be underpinned with the expected years of schooling. However, Hungary should advance by raising this indicator from 15.4 years to 17.2-17.4 years in order to attain the average.

### Conclusions

The study revealed the maximum theoretical potential of healthy life expectancy at birth for 2016, moreover, additional yearly accrual can be realised in the future. If the individuals become more conscious and take more responsibility for their health status and the environment, it is possible to release the uttermost part of the potential through prevention and effective public health interventions, plus greening each sector. Restoring environmental health is a must for harnessing the entire potential in healthy life expectancy. A new quality-oriented system approach within

the inseparable society-environment-economy framework is required: the emphasis should be put on the improvement of the healthy life expectancy in lieu of that of the life expectancy so that the growth in healthy life expectancy can outstrip that in life expectancy. The convergence between the two indicators necessitates the active participation of the individuals who can, in turn, only benefit from this process. Accelerating the transition towards a carbon-neutral economy and diminishing all kinds of pollution allow that current consumption level per capita can remain unaltered or surmounted without negative consequences even in case of increasing demographics provided that the consumption bundle rests on consumer goods and services, which are efficient in resource use and coupled with low emission levels.
